Eligibility:

The prize is open to anyone from amongst the public/institutions/voluntary organizations displaying outstanding merit, achieving particularly effective results in the conservation and improvement of Environment. The term Environment will be interpreted in the broadest sense possible. The following is an illustrative list of areas of work. This list is not exhaustive.

1. Control of Pollution.
2. Protection & Conservation of Natural Resources.
3. Innovative cleaner technology if any implemented
4. Energy Conservation
5. Development of green belt, etc.

Criteria for Award:

The public/institutions/voluntary organizations that fulfill the above criteria may send their nomination (Three Copies) with full particulars in the prescribed form given below, so as to reach The Regional Administrator, Mahe on or before 21.06.2010.

The application should be accompanied by an explanatory note in three copies covering not more than five standard pages. This note should indicate the identity of the candidate and the work accomplished may be supplemented by the requisite documents.

6. Length of Service and the goals pursued.
7. Information regarding the nature of the undertaking and a qualitative & quantitative assessment of results.
8. The contributions made towards promotion or improvement and protection of Environment (Support with evidence and specific instances).
9. Any other information, which is considered relevance in this regard.
